Beliau saat ini merupakan Wakil Sekretaris Komisi Fatwa MUI, Pemimpin Pondok Pesantren Daarul Rahman, serta Ketua DPS Indomobil Finance Syariah, Wakil Ketua Lembaga Bahtsul Masail PBNU dan memiliki pengalaman yang luas di berbagai organisasi keagamaan dan kemasyarakatan, antara lain di Ikatan Cendekiawan Muslim Indonesia (ICMI) dan di Nadhatul Ulama (NU). Beliau juga aktif sebagai pembicara maupun moderator di berbagai seminar dan program pelatihan. Beliau memperoleh gelar Sarjana dari Fakultas Syariah, Medina Islamic University, Arab Saudi, pada tahun 1997.
